Item 5.07. Submission of Matters to a Vote of Security Holders.

The RealNetworks, Inc. annual meeting of shareholders was held on October 1, 2018. According to the inspector of election, shareholders present in person or by proxy, representing 33,319,421 shares, or 88.59%, of RealNetworks common stock entitled to vote (generally entitled to one vote per share), voted on each proposal presented as follows: Proposal 1 – Election of Directors. The shareholders elected two directors of RealNetworks to hold office for a three-year term or until his successor has been duly elected and qualified (or, if earlier, such director’s removal or resignation from the Board of Directors).
