The following are Q&A materials used by Central Pacific Financial Corp. and posted on its website ([www.cpbi.com](http://www.cpbi.com)) on April 29, 2003.

**Q/A for Meeting Release for website**

1. Why is CPF requesting a special meeting of CB shareholders?

CB shareholders, the owners of CB Bancshares, should have a voice in the future of their company. By requesting this meeting, CPF takes a first step to help ensure that the views of CB shareholders on our offer are heard by CB's board and management. This special meeting would give CB shareholders the chance to vote on whether we can acquire a majority or more of CB shares, after other conditions are met, as a first step.

2. What does Hawaii law call for?

CPF delivered a letter and information statement to CB Bancshares requesting the special meeting of CB shareholders. The Hawaii Control Share Acquisitions Statute stipulates that a prospective buyer, like us, may call for a special shareholder meeting. CB is required to respond and set a date within five calendar days of receiving the request, or by May 3<sup>rd</sup>, and must hold that meeting within 55 calendar days of receiving the request, or before June 22. In the meantime, CPF continues to be open to meaningful, friendly discussions, which we've sought for many weeks.

3. Does this represent the final merger vote?

No. At this meeting, CB shareholders will vote only on whether we can acquire a majority or more of CB shares by our planned exchange offer, or otherwise. If at least a majority of the CB shares, excluding the 88,741 shares we own, are in favor, we can proceed after other conditions are met. If we are successful in acquiring at least a majority of the CB shares, we remain committed to completing a successful merger as a final step that will deliver the many benefits a stronger, locally focused bank can provide to shareholders, customers, employees, and the State of Hawaii.

**FORWARD LOOKING INFORMATION**

This document contains forward-looking statements within the meaning of the Private Securities Litigation Reform Act of 1995. Such statements include, but are not limited to, (i) statements about the benefits of a merger between Central Pacific Financial Corp. ( CPF ) and CB Bancshares, Inc. The following factors, among others, could cause actual results to differ materially from the anticipated results or other expectations expressed in the forward-looking statements: (1) the business of CPF and CBBI may not be integrated successfully or such integration may be more difficult, time-consuming or costly than expected; (2) expected revenue synergies and cost savings from the merger may not be fully

realized or realized within the expected time frame; (3) revenues following the merger may be lower than expected; (4) deposit attrition, operating costs, customer loss and business disruption, including, without limitation, difficulties in maintaining relationships with employees, customers, clients or suppliers, may be greater than expected following the merger; (5) the regulatory approvals required for the merger may not be obtained on the proposed terms; (6) the failure of CPF's and CBBI's shareholders to approve the merger; (7) competitive pressures among depository and other financial institutions may increase significantly and may have an effect on pricing, spending, third-party relationships and revenues; (8) the strength of the United States economy in general and the strength of the Hawaii economy may be different than expected, resulting in, among other things, a deterioration in credit quality or a reduced demand for credit, including the resultant effect on the combined company's loan portfolio and allowance for loan losses; (9) changes in the U.S. legal and regulatory framework; and (10) adverse conditions in the stock market, the public debt market and other capital markets (including changes in interest rate conditions) and the impact of such conditions on the combined company's activities.

With respect to financial projections for CBBI contained in this document, neither CBBI nor any analyst has published any information for 2003, 2004 or 2005. Therefore, management of CPF has created its own financial model for CBBI based on CBBI's historical performance and CPF's assumptions regarding the reasonable future performance of CBBI on a stand-alone basis. These assumptions may or may not prove to be correct. The assumptions are inherently subject to significant uncertainties and contingencies, many of which are beyond the control of CBBI. There is no assurance that these projections will be realized and actual results are likely to differ significantly from such projections.

On April 28, 2003, CPF filed with the SEC a registration statement on Form S-4 to register the CPF shares to be issued in a proposed exchange offer, and subject to future developments, CPF intends to file one or more proxy statements for solicitation of proxies from CPF shareholders, and may file one or more proxy statements for solicitation of proxies from CBBI shareholders, in connection with special meetings of such shareholders at a date or dates subsequent hereto and may file a tender offer statement. The registration statement is not final and will be further amended. Investors and security holders are urged to read the registration statement, and proxy statements (when available) and any other relevant documents filed with the SEC, as well as any amendments or supplements to those documents, because they will contain important information. Investors and security holders may obtain a free copy of the registration statement, any amendments thereto (when available) and proxy statements (when available) and other relevant documents, including the tender offer statement if filed, at the SEC's Internet web site at ([www.sec.gov](http://www.sec.gov)).
