Item 1.01 **Entry into a Material Definitive Agreement**

On June 28, 2005, The AES Corporation issued a press release announcing that it had amended its Senior Credit Facility. The amendment, among other things, reduced the interest rate on both the term and revolving credit facilities, extended the maturity date of the revolving credit facility to June 23, 2010 and amended some of the covenants to provide the Company with greater flexibility.
