**Item 8.01. Other Events.**

On April 30, 2008, Hawaiian Airlines, Inc., the Registrant's principal operating subsidiary ( Hawaiian ), issued a press release announcing that it has reached a settlement of its lawsuit with Mesa Air Group, Inc. ( Mesa ) regarding Mesa's misuse of confidential and proprietary information obtained during the Registrant's Chapter 11 plan of reorganization in 2004. Under the terms of the settlement agreement, Hawaiian will receive a cash payment of \$52.5 million and Mesa will withdraw its appeal of the \$80 million judgment (plus interest, attorneys' fees and costs) awarded against Mesa by the United States Bankruptcy Court (the Bankruptcy Court ) in October 2007. The settlement agreement is subject to Bankruptcy Court approval.
