**MTS Announces Subscriber Growth Numbers for January 2009**

**Moscow, Russian Federation** Mobile TeleSystems OJSC ( MTS NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that its consolidated subscriber base reached **91.40 million users on January 31, 2009**.

During January, MTS consolidated subscriber base increased by 0.07 million subscribers with 280 thousand subscribers added in Moscow. In Turkmenistan, the Company reached a milestone with one million subscribers.
