Connie Lau: This is an opportunity when our utility combines with NextEra Energy to really have them help us accelerate that movement towards clean energy

Jim Robo: So, for NextEra Energy, Hawaiian Electric will become the third principal subsidiary within our company. This transaction is very consistent with our core strategy of growing our regulated footprint as well as having other opportunities to invest in the renewables space as well as infrastructure.

One will be shares of stock in NextEra Energy, and so they will benefit from the combined strength of both Hawaiian Electric within the NextEra Energy family of companies as their third strategic business unit. And then they will also get a share of stock in American Savings Bank.

It will also keep the same names, Hawaiian Electric, Maui Electric and Hawaii Electric Light.
