Tremor Video, Inc. (the *Registrant*) is filing this Registration Statement on Form S-8 for the purpose of registering an additional 1,000,000 shares of its common stock, par value \$0.0001 per share (the *Common Stock*), issuable to eligible persons under the 2013 Equity Incentive Plan, as amended (the *2013 Plan*), which Common Stock is in addition to the shares of Common Stock registered on the Registrant s Forms S-8 filed on June 28, 2013 (File No. 333-189682), July 23, 2014 (file No. 333-197585) and February 9, 2015 (file No. 333-201985) (*collectively, Prior Registration Statements*.). The additional 1,000,000 shares of Common Stock have become reserved for issuance as a result of an amendment approved by the Registrant s stockholders at the 2015 Annual Meeting of Stockholders. Pursuant to General Instruction E to Form S-8, this Registration Statement hereby incorporates by reference the contents of the Prior Registration Statements referenced above.
