- (3) Each restricted stock unit ("RSU") had the economic equivalent of one share of CIT common stock.  
 The restricted stock units settled 50% in stock and 50% in cash, which was deemed to occur through an acquisition of 100% of the
- (4) underlying shares of CIT common stock and a simultaneous disposition to the issuer of 50% of the underlying shares of CIT common stock.
