The Option has an exercise price equal to the closing price of the Issuer's Common Stock on February 24, 2006, which was \$20.34. The closing price of the Issuer's Common Stock on March 31, 2006 was \$19.27. The vesting commencement for the Restricted Stock and the Option is retroactive to February 24, 2006. The Option vests in four equal annual installments commencing one year after that date.
