Mr. Leonard disclaims indirect beneficial ownership of these shares of common stock except to the extent of his pecuniary interest therein, and the inclusion of these shares in this Form 4 shall not be deemed an admission of his indirect beneficial ownership of all of the reported shares for purposes of Section 16 or for any other purpose.
