The Restricted Stock Units (RSUs) will be settled solely with Issuer Common Stock upon an annual vesting schedule as provided for in the Award Agreement for the RSUs as follows: 361 shares not later than November 15, 2013, 350 shares not later than November 15, 2014, and 351 shares not later than November 15, 2015.
- (2) 1,062 Market Share Units (Common Stock equivalents) were granted pursuant to the 2007 Stock Incentive Plan. The Market Share Units (MSUs) will be settled solely with Issuer Common Stock upon performance vesting as provided for in the Award Agreement for the MSUs following a 3-year performance measurement period.
- (3) Total includes 1,570,280 shares held in WD-40 Company Profit Sharing Plan (Company Stock Fund) account.
