The Market Share Units (MSUs) will be settled solely with Issuer Common Stock upon performance vesting as provided for in the Award Agreement for the MSUs following a 3-year performance measurement period.
- (4) Total includes 1,606,491 shares held in WD-40 Company Profit Sharing Plan (Company Stock Fund) account. Total also includes 6,800 Restricted Stock Units, of which 2,829 are subject to future vesting, 1,671 Market Share Units, all of which are subject to future vesting, and 1,156 PSUs, all of which are vested.
