- (1) High River Limited Partnership ("High River") directly beneficially owns 12,156,927 Shares, Icahn Partners LP ("Icahn Partners") directly beneficially owns 18,705,098 Shares, Icahn Partners Master Fund LP ("Icahn Master") directly beneficially owns 19,759,902 Shares, Icahn Partners Master Fund II LP ("Icahn Master II") directly beneficially owns 7,056,392 Shares, and Icahn Partners Master Fund III LP ("Icahn Master III") directly beneficially owns 3,106,304 Shares.
- (2) Barberrry Corp. ("Barberrry"), is the sole member of Hopper Investments LLC ("Hopper"), which is the general partner of High River. Beckton Corp. ("Beckton") is the sole stockholder of Icahn Enterprises G.P. Inc. ("Icahn Enterprises GP"), which is the general partner of Icahn Enterprises Holdings L.P. ("Icahn Enterprises Holdings"). Icahn Enterprises Holdings is the sole member of IPH GP LLC ("IPH"), which is the general partner of Icahn Capital LP ("Icahn Capital"). Icahn Capital is the general partner of each of Icahn Onshore LP ("Icahn Onshore") and Icahn Offshore LP ("Icahn Offshore"). Icahn Onshore is the general partner of Icahn Partners.
