(1) Represents an award of performance based restricted stock units granted under the Issuer's 2006 Equity Incentive Plan. These restricted stock units vest in four equal annual installments on February 28, 2014, August 27, 2014, August 27, 2015, and August 27, 2016, subject to the terms and conditions set forth in the applicable restricted stock unit award agreement.

(2) Reflects the number of shares of common stock withheld by the Issuer to pay the tax liability of the Reporting Person in connection with the settlement of vested restricted stock units previously granted to the Reporting Person.

(3) Represents the transfer of shares to a trust (the "Trust") of which the Reporting Person is trustee.
