On December 7, 2012, the reporting person was granted 18,228 Restricted Share Units ("RSUs") vesting in two installments; 9,114 RSUs vesting on December 7, 2013 and 9,114 RSUs vesting on December 7, 2014. Subsequently, the Compensation Committee made the determinations to satisfy the RSU award by delivering common shares rather than cash.
