- (1) The Convertible Debenture is redeemable by the Issuer using shares of the Issuer's Common Stock at a price per share equal to the lesser of (i) \$.90, and (ii) 85% of the average closing prices on the ten days immediately prior to the date of redemption. In accordance with the terms of the Convertible Debenture, the Convertible Debenture may be converted by the reporting person at any time while outstanding, and the Issuer is required to redeem (in cash or in shares) 1/30th of the outstanding amount of the Convertible Debenture each month during its term. On September 4th, the Issuer effected the September redemption using shares of Common Stock having a value of \$.29 per share, resulting in the issuance to the reporting person of 28,851 shares of Common Stock.
- (2) This amount does not include 82,938 shares of Common Stock owned directly by the reporting person.
