- (1) Grant was issued in connection with the transition provisions of the Company's revised independent director compensation plan (the "Plan"). The options shall vest in twelve equal installments of 2,500 shares with the first vesting date being December 31, 2011, followed by quarterly vesting thereafter, subject to accelerated vesting upon a change of control as described under the terms of the Plan.
- (2) Represents 100% of Mr. Sheft's quarterly board compensation granted pursuant to the Plan with a grant date fair value (as measured by the Black-Scholes option valuation model) of \$22,500.
