- (1) Represents the award of Restricted Stock Units ("RSUs") under the Casella Waste Systems, Inc. ("Casella") 2006 Stock Incentive Plan. Each RSU represents a contingent right to receive one share of Casella's Class A Common Stock.
- (2) These RSUs vest in three equal annual installments beginning on June 14, 2012, and are being reported upon vesting pursuant to Section 16(a) of the Securities Exchange Act of 1934 and applicable regulations thereunder.
- (3) Reflects the settlement of vested RSUs for shares of Class A Common Stock.
- (4) Held in trust for the benefit of Mr. Casella's children. Mr. Casella disclaims beneficial ownership of these securities to the extent to which he does not have an actual pecuniary interest in such securities.
- (5) These RSUs vest in three equal annual installments beginning on June 16, 2011, and are being reported upon the vesting pursuant to Section 16(a) of the Securities Exchange Act of 1934 and applicable regulations thereunder.
