**Item 7.01. Regulation FD Disclosure**

On November 13, 2008, Casey's General Stores, Inc. (the "Company") reported October 2008 same-store sales results for stores open for one full year. Same store gasoline gallons sold increased 3.1% in October 2008 compared to October 2007. The gasoline margin was above the Company's fiscal 2009 goal of 10.8 cents per gallon. The average retail price of gasoline sold during October 2008 was \$2.70 per gallon. Same-store sales of grocery and other merchandise increased 5.6% and prepared food and fountain same-store sales increased 9.8% in October 2008 compared to October 2007.
