(2) Consists of (i) 3,997,363 shares held by Monaco Partners, L.P. ("Monaco Partners") and (ii) 52,674 shares held by JHC Investments, LLC ("JHC LLC"). Clark Ventures, an entity controlled by James H. Clark, is the general partner of Monaco Partners. Monaco Partners is the sole member of JHC LLC.

(3) The 17,860 shares were sold through separate trades, with the sale prices ranging from \$10.50 to \$10.75, and at a weighted average sale price of \$10.6118.
