Upon the exchange of one Och-Ziff Operating Group A Unit for one Class A Share, one Class B Share will be canceled for no consideration.
- In connection with the separation of a certain partner from each of the Operating Group Partnerships, the departing partner's Och-Ziff

 (4) Operating Group A Units were reallocated pro-rata among the remaining partners in accordance with the partnership agreements of the Operating Group Partnerships.
