("Allscripts"), Arsenal Merger Corp. and Eclipsys Corporation (the "Merger Agreement") in exchange for 180,519 shares held directly and 28,013 Deferred Stock Units of Eclipsys Corporation. On the effective date of the merger, the closing price of Allscripts Healthcare Solutions, Inc. common stock was \$17.47 per share.
 - (2) Received pursuant to the Merger Agreement in exchange for a stock option to acquire 125,000 shares of Eclipsys Corporation common stock for \$8.88 per share.
