(1) This transaction was executed in multiple trades at prices ranging from \$34.22 to \$35.12. The price reported above reflects the weighted average purchase price. The Reporting Person hereby undertakes to provide upon request to the SEC staff, the issuer or a security holder of the issuer full information regarding the number of shares and prices at which the transaction was effected.

(2) Each RSU represents a contingent right to receive one share of KLA-Tencor common stock.

(3) Does not include performance-based RSUs, if any, held by the Reporting Person for which an assessment has not yet been made regarding the achievement of the applicable performance goals. Any such holdings will be reported on Form 4 within two business days of the date such assessment is made.

(4) Represents the remaining unexercised portion of a stock option granted on November 10, 2000, granting the Reporting Person the right to purchase up to 14,291 shares of KLA-Tencor common stock. 3,500 shares subject to this stock option vested on the one-year anniversary of the grant date, and 1/48 of the remaining 10,791 shares vested on each monthly anniversary thereafter until November 10, 2005.

(5) Represents a stock option granted on November 10, 2000, granting the Reporting Person the right to purchase up to 3,209 shares of KLA-Tencor common stock. 1/48 of the total number of shares subject to this stock option vested on the 13-month anniversary of the grant date and on each monthly anniversary thereafter until November 10, 2005.
