TA/Atlantic and Pacific IV L.P. distributed 408,236 shares to its partners of which TA Associates AP IV L.P. received 83,991 shares. TA Associates AP IV L.P. then distributed 2,467 shares to the reporting person in a pro rata distribution for no consideration in a transaction exempt under Rule 16a-9(a).

- (3) TA Subordinated Debt Fund L.P. distributed 135,264 shares to its partners of which TA Associates SDF LLC received 29,211 shares. TA Associates SDF LLC then distributed 1,155 shares to the reporting person in a pro rata distribution for no consideration in a transaction exempt under Rule 16a-9(a).
