- (3) The issuer's outside administrator for the employees' 401(k) plan holds issuer stock in a pooled fund as a participant investment option. The unit value can fluctuate with fluctuations in the value of the issuer common stock and the daily cash position. The number of shares of issuer stock attributable to the reporting person can be determined at any time by first multiplying the number of units in the reporting person's account by the then current unit price and dividing the total by the price of the issuer common stock. As of 4/4/2012, the reporting person held an equivalent of 149.527 shares in the issuer 401(k) Plan. The 401(k) plan is a "Qualified Plan" as defined in Rule 16b-3(b)(4).
