 On 02/23/2010, the reporting person was granted an option to purchase 114,929 shares of Common Stock. The option vests based upon (1) time (five equal annual installments that began on 02/23/2011) and performance (investment returns to investment funds affiliated with Bain Capital Partners, LLC, The Carlyle Group and Thomas H. Lee Partners, L.P. (collectively, the "Sponsors")) criteria.  
 As a result of the sale of shares by the Sponsors on 04/04/2012, the performance criteria was met with respect to 36,742 shares of common stock subject to this option award, resulting in vesting of the option as to 14,697 shares and an additional 22,045 shares that are (2) eligible to vest in three equal annual installments beginning on 02/23/2013. In total, following this event, the performance criteria has been met with respect to an aggregate of 69,547 shares of common stock subject to this option award, with 27,817 of such shares vested and the remaining 41,730 of such shares eligible to vest in three equal annual installments beginning on 02/23/2013.  
 In accordance with applicable rules, the number of Derivative Securities Beneficially Owned Following Reported Transactions reflects (3) only the shares issuable upon exercise of the reported option award and does not include shares of common stock issuable upon the exercise of other option awards that have been previously reported.
