Mr. Koontz disclaims beneficial ownership of the reported securities, except to the extent of his pecuniary interest therein.

(2) Paul G. Koontz is the trustee of the Paul Koontz 2010 Annuity Trust.

Andrea Koontz, Spouse of Paul G. Koontz, is the Trustee of the Andrea Koontz 2010 Annuity Trust.
