SCHEDULE 13D

Reference is hereby made to the statement on Schedule 13D filed with the Securities and Exchange Commission on May 9, 2011, as amended on March 9, 2012, and as amended on August 22, 2012 (the "Schedule 13D"), with respect to the Common Stock, par value \$0.01 per share (the "Common Stock") of StarTek, Inc., a Delaware corporation (the "Company" or "Issuer"). Capitalized terms not otherwise defined herein are used as defined in the Schedule 13D. The Reporting Persons hereby amend and supplement the Schedule 13D as follows.

Item 3. Source and Amount of Funds or Other Consideration.

Item 3 is hereby amended and restated in its entirety to read as follows:

The aggregate purchase price of the 1,147,525 shares of Common Stock beneficially owned by the Reporting Persons is approximately \$4,166,330, not including brokerage commissions, of which approximately \$3,798,457 was funded with partnership funds of Privet Fund LP, \$335,273 was funded with assets under separately managed accounts with Privet Fund Management LLC, and \$32,600 was funded with personal assets of Mr. Rosenzweig. Mr. Rosenzweig was granted 7,874 of his shares by the Company as director compensation. The participants may have effected purchases of the Company's Shares through margin accounts maintained with prime brokers, who may have extended margin credit as and when requested to open or carry positions in the margin accounts, subject to applicable federal margin regulations, stock exchange rules, and such broker's credit policies.

Item 5. Interest in Securities of the Issuer.

Item 5 is hereby amended and restated in its entirety to read as follows:

(a) As of the close of business on May 23, 2013, the aggregate number and percentage of shares of Common Stock beneficially owned by the Reporting Persons collectively is 1,147,525 shares (the "Shares"), or approximately 7.5% of the outstanding Common Stock of the Company (calculated based on information included in the Form 10-Q filed by the Company for the quarterly period ended March 31, 2013, which reported that 15,334,738 shares of Common Stock were outstanding as of May 6, 2013).
