In accordance with Section 198-202 of the UK Companies Act 1985, the Company has received notification from Deutsche Bank AG as follows:

That on the basis that the relevant issued share capital of the Company is 567,110,072 ordinary shares, Deutsche Bank AG and its subsidiary companies have a notifiable interest in 34,023,810 ordinary shares in the Company amounting to 5.99%.

Deutsche Bank AG is a corporation domiciled in Frankfurt, Germany, of which Deutsche Bank AG London is a branch.

On 25 November 2005, the Company disclosed that Deutsche Bank AG had a notifiable interest in 38,663,392 shares (6.82%).
