Unilever NV announces that on 26 April 2007 it purchased 450,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at a price of euro 22.825 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 97,473 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 61,584,626 Unilever NV ordinary shares in treasury, and has 1,653,143,074 Unilever NV ordinary shares in issue (excluding treasury shares).
