Unilever NV announces that on 17 September 2007 it purchased 250,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 22.290 and euro 22.550 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 2,514 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 93,920,788 Unilever NV ordinary shares in treasury, and has 1,620,806,912 Unilever NV ordinary shares in issue (excluding treasury shares).
