On December 18, 1996, Microsoft Corporation (Microsoft) filed a Registration Statement pursuant to Rule 462(b) on Form S-3, SEC 1933 Act Number 333-18195 (the Registration Statement) to cover \$100 of Microsoft s 2¾% Convertible Exchangeable Principal-Protected Series A Preferred Shares (the Series A Shares ¹).

The Registration Statement was filed in order to register the Series A Shares, which were exchangeable, in certain defined circumstances, into convertible notes and/or shares of Microsoft Common Stock.

As all Series A Shares were converted to Microsoft Common Stock on December 15, 1999, Microsoft hereby de-registers its Series A Share registered pursuant to the Registration Statement.

¹ Represents approximately 1.25 Series A Shares at a price, determined on December 18, 1996, to be \$79.875.
