The Form 11-K for the Liberty National Life Insurance Company 401(K) Plan (the 401(K) Plan ) for the period ended December 31, 2004 cannot be timely filed by its June 29, 2005 due date. The record keeper/custodian for the 401(K) Plan was changed in 2004 from Metavante Retirement Plan Services to ING National Trust with all blackout periods ending December 21, 2004. Because the plan has a December 31 fiscal year end, in 2004 the plan had two different record keepers/custodians with different systems. Accordingly, there have been difficulties in obtaining and coordinating all the information necessary to complete the Form 11-K by the June 29, 2005 filing deadline.
