By letter dated March 28, 2006, the Company reported that a holder of Company s Convertible Notes exercised it conversion right. Hence, the financial indebtedness of the Company shall be reduced in US\$ 1,057,265 and an increase of 1,939,935 ordinary shares face value pesos 1 each was made. The conversion was performed according to terms and conditions established in the prospectus of issuance at the conversion rate of 1.83486 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion the amount of shares of the Company goes from 379,076,627 to 381,016,562. On the other hand, the amount of registered Convertible Notes is US\$ 50,323,732.
