Item 5 of this Schedule 13D is amended to add the following:

(a)-(b) Mr. Buffett owns, and has the sole power to vote and to dispose of, 350,000 shares of Class A Common Stock and 3,142,440 shares of Class B Common Stock, representing approximately 31.02% of the outstanding shares of Class A Common Stock, 25.31% of the outstanding shares of Class B Common Stock, 30.72% of the aggregate voting power of the outstanding shares of both classes, and 29.49% of the economic interest of the outstanding shares of both classes.

As executor of Mrs. Buffett's estate, Mr. Buffett has sole power to vote and to dispose of the 23,322 shares of Class A Common Stock and 177 shares of Class B Common Stock currently held by her estate, representing approximately 2.07% of the outstanding shares of Class A Common Stock, 1.96% of the aggregate voting power of the outstanding shares of both classes, and 1.51% of the economic interest of the outstanding shares of both classes.

(c) On July 21, 2006, Mr. Buffett donated 17,500 shares of Class B Common Stock to each of the Susan A. Buffett Foundation and the Howard G. Buffett Foundation pursuant to his previously announced irrevocable pledges to these foundations.

On July 25, 2006, Mr. Buffett donated 17,500 shares of Class B Common Stock to the NoVo Foundation pursuant to his previously announced irrevocable pledge to this foundation and 5,000 shares of Class B Common Stock to another charitable foundation.

On July 27, 2005, Mr. Buffett donated 50,000 shares of Class B Common Stock to the Susan Thompson Buffett Foundation pursuant to his previously announced irrevocable pledge to this foundation.

On August 24, 2005, Mr. Buffett donated 500,000 shares of Class B Common Stock to the Bill and Melinda Gates Foundation pursuant to his previously announced irrevocable pledge to this foundation.
