This Current Report on Form 8-K shall not constitute an offer to sell, or the solicitation of an offer to buy, the securities described herein, nor shall there be any sale of these securities in any jurisdiction or state in which such offer, solicitation or sale would be unlawful.

**Item 1.01 Entry into a Material Definitive Agreement.**

On May 3, 2007, Insmmed, Incorporated, a Virginia corporation ( Insmmed ), entered into a placement agency agreement (the Placement Agency Agreement ) with C.E. Unterberg, Towbin, LLC ( Unterberg ) as exclusive placement agent relating to a proposed registered direct offering of shares of Insmmed s common stock, par value \$0.01 per share ( Common Stock ), and warrants (the Warrants ) to purchase Common Stock to certain investors (the Offering ). A copy of the Placement Agency Agreement is filed as Exhibit 1.1 to this Current Report and is incorporated herein by reference. The closing for the sale of shares of Common Stock and Warrants is expected to take place on or about May 4, 2007, subject to the satisfaction of customary closing conditions. Insmmed will pay the placement agent a fee equal to 6% of the gross proceeds of the Offering equal to approximately \$1.09 million, and will pay estimated expenses of the Offering equal to \$200,000.

In addition, on May 3, 2007, Insmmed entered into definitive subscription agreements with certain investors relating to the sale of an aggregate of 20,255,367 units, each unit consisting of (i) one (1) share of Common Stock and (ii) one Warrant to purchase 0.1 shares of Common Stock at an exercise price of \$1.10 per share, for a purchase price of \$0.90 per unit. Units will not be issued or certificated. The shares of Common Stock and Warrants are immediately separable and will be issued separately. The Warrants will be exercisable beginning on November 3, 2007 and until May 3, 2012. A copy of the form of subscription agreement is filed as Exhibit 10.1 to this Current Report and is incorporated herein by reference. A copy of the form of Warrant to be issued by Insmmed is filed as Exhibit 4.1 to this Current Report and is incorporated herein by reference.

The shares of Common Stock and Warrants (and the shares of Common Stock issuable from time to time upon exercise of the Warrants) being offered by Insmmed in this Offering were registered under an existing shelf registration statement on Form S-3 (Registration No. 333-131535), which was declared effective by the Securities and Exchange Commission on February 14, 2006.

On May 4, 2007, Insmmed issued a press release announcing the pricing of the Offering described in Item 1.01 above. A copy of this press release is furnished as Exhibit 99.1 to this Current Report.
