Estimated Unaudited Assets Under Management

In addition, the Company is disclosing to investors in the private investment funds that it manages that, as of July 1, 2008, the estimated unaudited amount of assets under management (AUM) was approximately \$33.3 billion, which reflects a net decrease in AUM of approximately \$504 million. The decrease in AUM is inclusive of performance for the month ended June 30, 2008 and capital flows as of July 1, 2008.
