This Report of Foreign Private Issuer on Form 6-K is deemed filed for all purposes under the Securities Act of 1933, as amended, and the Securities Exchange Act of 1934, as amended.

On December 24, 2010, in accordance with the government policy to gradually reduce its holdings in government-controlled enterprises, Korea Electric Power Corporation ( KEPCO ) sold 2,248,000 common shares of its subsidiary Korea Plant Service & Engineering Co., Ltd. ( KPS ) in the over-the-counter market, which resulted in a reduction of KEPCO 's equity interest in KPS from 80.000% to 75.004%. The proceeds to KEPCO from the sale of the KPS shares was approximately Won 150 billion, at Won 66,940 per share.
