DTE Energy Company (DTE Energy) is furnishing the Securities and Exchange Commission (SEC) with its earnings release issued April 27, 2012, announcing financial results for the quarter ended March 31, 2012. In its earnings release and the slide presentation discussed below, DTE Energy reaffirms its 2012 operating earnings per share guidance of \$3.65-\$3.95 per share.

These items may fluctuate significantly from period to period and may have a significant impact on reported earnings.
