Estimated Unaudited Returns

The following information is being provided to investors in the private investment funds that affiliates of Och-Ziff Capital Management Group LLC (collectively, the Company) manage with respect to the estimated performance of the Company's most significant master funds for the month ended April 30, 2013. The following information is not necessarily indicative of the Company's anticipated financial results.

- Monthly performance data are based on management's estimates as of the date hereof for performance of the referenced funds from April 1, 2013 to April 30, 2013. Such data may change upon completion of the Company's month-end valuation procedures, and any changes could be material.
- Net return represents a composite of the average return of the feeder funds that comprise each of the Company's most significant master funds. Net return is presented on a total return basis, net of all fees and expenses (except incentive income on unrealized gains attributable to investments that the Company, as investment manager, determines lack a readily ascertainable fair value, are illiquid or otherwise should be held until the resolution of a special event or circumstance (Special Investments) that could reduce returns on such Special Investments at the time of realization) and includes the reinvestment of all dividends and other income. Performance includes realized and unrealized gains and losses attributable to Special Investments and initial public offering investments that are not allocated to all investors in the feeder funds. Investors that were not allocated Special Investments and/or initial public offering investments may experience materially different returns.
- Year-to-date performance data are based on management's estimates as of the date hereof for the performance of the referenced funds from January 1, 2013 to April 30, 2013. Such data may change upon completion of the Company's month-end valuation procedures, and any changes could be material.

Estimated Unaudited Assets Under Management

In addition, the Company is disclosing to investors in the private investment funds that it manages that, as of May 1, 2013, the estimated unaudited amount of assets under management was approximately \$35.6 billion, which reflects a net increase of approximately \$700 million since April 1, 2013. The Company's estimate of assets under management is inclusive of performance for the month ended April 30, 2013 and capital flows as of May 1, 2013.

Assets under management includes assets attributable to our multi-strategy funds, credit funds, collateralized loan obligations (CLOs), real estate funds and other alternative investment vehicles we manage. Management fees and incentive income earned on our assets under management may vary depending on the asset class, performance measurement period, amount of capital committed by investors, and other factors related to a particular fund or other investment vehicle.
