**Item 1.01 Entry into a Material Definitive Agreement**

Reference is made to that certain US/Canada Manufacturing and PP&S Agreement dated as of July 1, 2010, as amended (collectively, the US/Canada Agreement ), by and between Warner-Elektra-Atlantic Corporation ( WEA ) and Cinram International Inc., Cinram Manufacturing LLC and Cinram Distribution LLC (collectively, Cinram ) and a letter dated August 31, 2012 (the Reinstatement and Assignment Letter ) under which WEA consented to Cinram s assignment of the US/Canada Agreement and certain other agreements to Cinram Group, Inc. (formerly Cinram Acquisition, Inc.) ( CGI ), with respect to operations in the United States, and to Cinram Canada Operations ULC ( Cinram Canada ), with respect to operations in Canada.

On September 29, 2014, pursuant to Section 5(a) of the US/Canada Agreement, WEA served Cinram, CGI and Cinram Canada the required ninety (90) days notice that WEA has elected to exercise its second option to renew the term of the US/Canada Agreement for an additional one (1)-year period. The term will now end on January 31, 2016.
