**ChipMOS REPORTS JANUARY 2015 REVENUE**

**Hsinchu, Taiwan, February 10, 2015** - ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and testing services ( OSAT ), today reported its unaudited consolidated revenue for the month of January 2015.

Revenue for the month of January 2015 was NT\$1,792.2 million or US\$56.4 million, a decrease of 5.9% from the month of December 2014 and an increase of 10.5% from the same period in 2014. All U.S. figures in this release are based on the exchange rate of NT\$31.75 to US\$1.00 as of January 30, 2015.
