As of the close of business on December 31, 2014, each of the Reporting Persons may be deemed to have beneficial ownership of 474,421 shares of Common Stock, which consists of (i) 181,541 shares of Common Stock held for the account of Cranshire Capital Master Fund, (ii) 28,685 shares of Common Stock held for the account of the Managed Account, (iii) 207,856 shares of Common Stock in the aggregate issuable upon exercise of certain warrants held by Cranshire Capital Master Fund (the Cranshire Warrants) and (iv) 56,339 shares of Common Stock in the aggregate issuable upon exercise of certain warrants held by the Managed Account (the Managed Account Warrants), all such shares of Common Stock represent beneficial ownership of approximately 4.9% of the Common Stock, based on (1) 9,374,082 shares of Common Stock issued and outstanding on October 31, 2014, as reported in the Form 10-Q filed by the Issuer on November 14, 2014, plus (2) 207,856 shares of Common Stock in the aggregate issuable upon exercise of the Cranshire Warrants, and (3) 56,339 shares of Common Stock in the aggregate issuable upon exercise of the Managed Account Warrants.
