As previously announced, on April 27, 2015, Fifth Third Bancorp (Fifth Third) entered into an accelerated share repurchase transaction with Barclays Bank PLC, with Barclays Capital Inc. acting as agent (Barclays) pursuant to which Fifth Third would purchase approximately \$155 million of its outstanding common stock. Fifth Third is repurchasing the shares of its common stock as part of its 100 million share repurchase program, previously announced on March 18, 2014.

On July 28, 2015, Fifth Third was notified by Barclays that effective Tuesday, July 28, 2015, they had finished purchasing shares under the April 27th agreement. A total of 6,704,835 shares were repurchased upon execution of the agreement, and an additional 842,655 shares were repurchased upon completion of the agreement. The additional shares are expected to settle on Friday, July 31, 2015. In total, 7,547,490 shares were repurchased under the April 27, 2015 agreement, at an average price of \$20.5366.

After the completion of April 27, 2015 agreement, Fifth Third had approximately 55.2 million shares of remaining repurchase authority under its share repurchase program previously announced on March 18, 2014.

Barclays and certain of its affiliates have performed, and in the future may perform, various financial advisory and other services for Fifth Third and Fifth Third's affiliates for which they have received, and may in the future receive, customary fees and expenses.
