Bain Capital Investors, LLC, a Delaware limited liability company (BCI), is the administrative member of each of the Reporting Persons.

The Reporting Persons have entered into a Joint Filing Agreement, dated February 16, 2016, pursuant to which the Reporting Persons have agreed to file this statement jointly in accordance with the provisions of Rule 13d-1(k)(1) under the Act.

This Schedule 13G is being filed on behalf of the Reporting Persons. As of the close of business on December 31, 2015, the following shares were held by the Reporting Persons:

Integral held 66,782,499 shares of Common Stock of the Company, representing approximately 32.0% of the Company's outstanding shares of Common Stock.

TCV held 195,478 shares of Common Stock of the Company, representing less than 0.1% of the Company's outstanding shares of Common Stock.

As a result of the foregoing and the relationships described in Item 2(a), the Reporting Persons may be deemed to beneficially own in the aggregate 66,977,977 shares of Common Stock of the Company, representing, in the aggregate, approximately 32.1% of the Company's outstanding shares of Common Stock. The percentage of the Company's outstanding shares of Common Stock held by the Reporting Persons is based on 208,962,744 shares of Common Stock outstanding as of November 25, 2015, as reported in the Company's Form 10-Q filed with the Securities and Exchange Commission on December 4, 2015.
