On December 29, 2017, Vulcan Materials Company (the Company) completed its previously announced acquisition of Aggregates USA, LLC (Aggregates USA) for a purchase price of \$900 million, subject to customary post-closing adjustments.

On December 29, 2017, the Company also completed its previously announced disposition of Aggregates USA's Tennessee assets and an aggregates quarry in Abingdon, VA to Blue Water Industries LLC, for a purchase price of \$290 million, subject to customary post-closing adjustments.
