First BanCorp (the Corporation) was unable to timely file with the Securities and Exchange Commission (the Commission) its Annual Report on Form 10-K for the year ended December 31, 2017 without unreasonable effort and expense. The Corporation requires additional time to complete, and its independent registered public accounting firm requires additional time to audit, certain items with respect to the Corporation's financial statements and the assessment of the Corporation's internal control over financial reporting for the year ended December 31, 2017. The Corporation intends to file its Annual Report on Form 10-K as soon as practicable but not later than the fifteenth calendar day following the prescribed due date.

As of the date of this filing, the Corporation expects that its audited financial statements will report results that are consistent with the results of operations reported in the January 29, 2018 earnings release.
