These options vested as follows: 5,000 on September 22, 1998, 5,000 vested on September 22, 1999, and 5,000 vested September 22, 2000. After this reported disposition, Mr. Yestrumskas has 150,800 options outstanding, of which 134,268 are exercisable.
