- (1) Restricted stock award vests 25% annually beginning on 2/11/2009 and for each of the following three years concluding February 11, 2012.
- The shares granted are performance based restricted shares. The number of performance-based shares awarded will vest on an annual basis, subject to continued service and based on the achievement of corporate performance measures. These measures consist of (i) annual revenue growth and (ii) annual "pro forma" net income growth, assessed each fiscal year over a period of four years. The number of performance-based shares is the target number of shares. The actual number of shares to be vested may be more or less than the target number, based on over- or under-achievement of the identified corporate performance measures, ranging from 150% to 0%.
