- (1) A year-end reconciliation by Mr. Kalnasy's financial advisor indicated that there were 179 greater shares of Belden stock in Mr. Kalnasy's account than the amount previously reported by the company. The company and Mr. Kalnasy's advisor have been unsuccessful in tracing this discrepancy, which likely pre-dates the 2004 merger of Belden Inc. and Cable Design Technologies. The purpose of this filing is to match the public record with reality.
